- 1) Enter all required data for the three tabs “Depositor”, “Declarer” and “Reporting Person”. All fields are mandatory. Pressing the load button allows to import the data from an existing AEOI report.
- 2) Select you valid and prepared OECD XML 1.0 standard document by pressing button “...” (2)
- 3) If the message reference and document reference IDs not yet generated you can check the “Generate IDs during export” checkbox, to generate (or replace) all message and document reference IDs during the export of the XML.
- 4) Finally export the file by pressing (4). Select the target folder. The filename will be generated according to Lux naming conventions.

### File Information

After a file is loaded or saved, the information about the file (name, last modified, absolute path) is displayed in the status pane of the detail area. The full path can be seen in the tooltip.
